SL(5)609 – Rheoliadau Tenantiaethau Busnes (Estyn Gwarchodaeth rhag Fforffediad etc.) (Cymru) (Coronafeirws) (Rhif 2) 2020

Gweithdrefn: Negyddol

Mae adran 82 o Ddeddf y Coronafeirws 2020 yn sicrhau na chaniateir gorfodi ailfynediad neu fforffediad am beidio â thalu rhent mewn perthynas â thenantiaethau busnes perthnasol yn ystod y cyfnod perthnasol ("relevant period"). Mae adran 82(12) o Ddeddf y Coronafeirws 2020 yn diffinio'r "relevant period" fel cyfnod sy'n dechrau ar 26 Mawrth 2020 ac sy'n dod i ben ar 30 Mehefin 2020, neu ar unrhyw ddyddiad diweddarach a bennir mewn rheoliadau a wneir gan yr awdurdod cenedlaethol perthnasol.

Gweinidogion Cymru yw'r "awdurdod cenedlaethol perthnasol" mewn perthynas â Chymru, a gallant felly wneud rheoliadau i ymestyn y "cyfnod perthnasol" i warchodaeth y tu hwnt i 30ain Mehefin 2020, a thrwy hynny gadw'r warchodaeth a ddarperir gan adran 82 y Ddeddf i'r dyddiad diweddarach a nodir yn y rheoliadau.

Estynnodd Rheoliadau Tenantiaethau Busnes (Estyn Gwarchodaeth rhag Fforffediad etc.) (Cymru)(Coronafeirws) 2020 y "cyfnod perthnasol" o 30 Mehefin 2020 hyd 30 Medi 2020.

Mae'r Rheoliadau hyn yn ymestyn y "cyfnod perthnasol" am dri mis arall i 31 Rhagfyr 2020. O ganlyniad, mae'r moratoriwm a ddarperir gan adran 82 o Ddeddf y Coronafeirws 2020 wedi ei estyn ymhellach hyd 31 Rhagfyr 2020.

SL(5)618 – The Health Protection (Coronavirus Restrictions) (No. 2) (Wales) (Amendment) (No. 11) (Blaenau Gwent, Bridgend, Merthyr Tydfil and Newport etc.) Regulations 2020

Procedure: Made affirmative

These Regulations amend the Health Protection (Coronavirus Restrictions) (No. 2) (Wales) Regulations 2020 (the “principal Regulations”). The amendments—

- designate Blaenau Gwent, Bridgend, and Merthyr Tydfil County Boroughs, and the City and County Borough of Newport, as local health protection areas that are subject to specific restrictions and requirements;
- provide that one of the requirements is that licensed premises must close at 11 p.m. in all local health protection areas (including Caerphilly County Borough);
- provide that it is a reasonable excuse for persons living in accommodation where certain facilities are shared to gather indoors as if they were a single household (this includes houses in multiple occupation and student accommodation);
- make minor amendments to the Welsh language text of regulation 14C of the principal Regulations.
