Y Gweinidog Iechyd a Gwasanaethau Cymdeithasol (Lesley Griffiths): Mae tua 3% o swyddi gwag ar gyfer meddygon a deintyddion ar draws gweithlu'r GIG yng Nghymru o hyd. Byddwn yn dal ati i gydweithio â sefydliadau GIG a Chymdeithas Feddygol Prydain i ddangos bod Cymru'n wlad ddeniadol i fyw a gweithio ynddi. Wrth gwrs, mae prinder meddygon mewn rhai arbenigeddau ar draws y Deyrnas Unedig.

13. Keith Davies: Will the Minister provide an update on the current position of medical vacancies in Wales. OAQ(4)0102(HSS) W

The Minister for Health and Social Services (Lesley Griffiths): There continues to be around 3% of medical and dental posts vacant across the NHS workforce in Wales. We continue to work with NHS organisations and the British Medical Association to show that Wales is an attractive place to live and work. There is, of course, a UK-wide shortage of doctors in some specialities.
