Mae'r Rheoliadau hyn yn diwygio Rheoliadau Adeiladu 2010 ("y Rheoliadau Adeiladu") a Rheoliadau Adeiladu (Arolygwyr Cymeradwy etc.) 2010 ("y Rheoliadau Arolygwyr Cymeradwy") mewn perthynas ag adeiladau ynni a eithrir yng Nghymru.

Trosglwyddwyd swyddogaethau o dan Ddeddf Adeiladu 1984 ("Deddf 1984") i wneud rheoliadau adeiladu a materion cysylltiedig i Weinidogion Cymru gan Orchymyn Gweinidogion Cymru (Trosglwyddo Swyddogaethau) (Rhif. 2) 2009 a ddaeth i rym ar 31 Rhagfyr 2011. Gwnaed eithriad o'r trosglwyddo mewn perthynas ag "adeiladau ynni a eithrir" sydd â'r ystyr a roddir i "excepted energy buildings" gan yr Atodlen i'r Gorchymyn hwnnw.

Roedd diwygiadau i'r Rheoliadau Adeiladu a'r Rheoliadau Arolygwyr Cymeradwy a wnaed gan yr Ysgrifennydd Gwladol o 31 Rhagfyr 2011 yn gymwys o ran Lloegr ac i adeiladau ynni a eithrir yng Nghymru. Roedd diwygiadau i'r Rheoliadau hynny a wnaed gan Weinidogion Cymru o 31 Rhagfyr 2011 yn gymwys o ran Cymru ac eithrio i adeiladau ynni a eithrir.

Mae adran 54 o Ddeddf Cymru 2017 yn dileu'r eithriad mewn perthynas ag adeiladau ynni a eithrir drwy wneud y ddarpariaeth angenrheidiol ar gyfer trosglwyddo swyddogaethau o dan Ddeddf 1984 ar gyfer y categori hwnnw o adeiladau o 1 Ebrill 2018.

Effaith y diwygiadau a wneir gan y Rheoliadau hyn yw cysoni'r darpariaethau yn y Rheoliadau Adeiladu a'r Rheoliadau Arolygwyr Cymeradwy mewn perthynas ag adeiladau ynni a eithrir yng Nghymru â'r

darpariaethau sy'n gymwys i adeiladau eraill yng Nghymru.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

Roedd erthygl 3(a) o Orchymyn 2009 yn darparu nad oedd swyddogaethau wedi eu trosglwyddo i'r graddau yr oeddent yn arferadwy mewn perthynas ag adeilad ynni a eithrir fel y'i diffinnir gan yr Atodlen i'r Gorchymyn hwnnw. Dileodd adran 54 o Ddeddf Cymru 2017 (p. 4) yr eithriad hwn drwy wneud y ddarpariaeth angenrheidiol ar gyfer trosglwyddo swyddogaethau o dan Ddeddf 1984 ar gyfer y categori hwnnw o adeiladau.

  - (ii) ar ddiwedd is-baragraff (b) hepgorer “; or”;
  - (iii) hepgorer is-baragraff (c);
- (b) hepgorer paragraff (6A);
- (c) ym mharagraff (9)—
  - (i) ar ddiwedd y diffiniad o “private street” hepgorer “and”;
  - (ii) hepgorer “special location” a’i ddiffiniad.

(2) Yn rheoliad 13 (manylion a phlantiau pan roddir hysbysiad adeiladu)—

- (a) ym mharagraff (1)—
  - (i) ar ddiwedd is-baragraff (b) mewnosoder “and”;
  - (ii) ar ddiwedd is-baragraff (c) hepgorer “; and”;
  - (iii) hepgorer is-baragraff (d);
- (b) hepgorer paragraff (1A).

(3) Yn rheoliad 14 (y planiau llawn) ym mharagraff (3)(a) hepgorer “, (1A)”.

(4) Yn rheoliad 16 (hysbysiad cychwyn a chwblhau camau penodol o’r gwaith)—

“(2) Subject to paragraph (8), a person carrying out building work shall not—

  - (a) cover up any excavation for a foundation, any foundation, any damp-proof course or any concrete or other material laid over a site; or
  - (b) cover up in any way any drain or sewer to which these Regulations apply, unless that person has given the local authority notice of intention to commence that work, and at least one day has elapsed since the end of the day on which the notice was given.

(3) Subject to paragraph (8), a person who has laid, haunched or covered any drain or sewer in respect of which Part H of Schedule 1 (drainage and waste disposal) imposes a requirement shall give notice to that effect to the local authority not more than five days after the completion of the work.”;

#### **Rhan 6 (gofynion effeithlonrwydd ynni)**

7.—(1) Yn rheoliad 21 (cymhwyso gofynion effeithlonrwydd ynni), ym mharagraff (4)—

- (a) ar ddiwedd is-baragraff (a) hepgorer “or”;
- (b) ar ddiwedd is-baragraff (b) mewnosoder “to heat the conservatory or porch; or”;
- (c) ar ôl is-baragraff (b), mewnosoder—  
“(c) in which a fixed heating appliance has been provided to heat the conservatory or porch.”

(2) Yn lle rheoliad 25 (y gofynion perfformiad ynni gofynnol ar gyfer adeiladau newydd) rhodder—

“25. The Welsh Ministers shall approve minimum energy performance requirements for new buildings, in the form of target CO<sup>2</sup> emission rates, which shall be calculated and expressed in accordance with the methodology approved pursuant to regulation 24.”

(3) Ar ôl rheoliad 25B (gofynion bron yn ddi-ynni ar gyfer adeiladau newydd) mewnosoder—

#### **“New buildings: minimum energy performance requirements**

25C. Minimum energy performance requirements must be approved by the Welsh

Ministers, calculated and expressed in accordance with the methodology approved pursuant to regulation 24, for—

- (a) new buildings (other than new dwellings), in the form of target primary energy consumption rates; and
- (b) new dwellings, in the form of target fabric performance values.”

(4) Yn lle rheoliad 26A (cyfradd effeithlonrwydd ynni adeiladwaith) a'r pennawd uwchben rhodder—

**“Primary Energy consumption rates for new buildings**

**26A.** Where a building (other than a dwelling) is erected, it must not exceed the target primary energy consumption rate for the building which has been approved pursuant to regulation 25C(a), applying the methodology of calculation and expression of the energy performance of buildings approved pursuant to regulation 24.”

(5) Ar ôl rheoliad 26A mewnosoder—

**“Fabric performance values for new dwellings**

**26B.** Where a dwelling is erected, it must not exceed the target fabric performance values for the dwelling which have been approved pursuant to regulation 25C(b), applying the methodology of calculation and expression of the energy performance of buildings approved pursuant to regulation 24.”

(6) Yn rheoliad 27A (cyfrifiadau cyfraddau effeithlonrwydd ynni adeiladwaith)—

- (a) yn lle'r pennawd rhodder “Primary energy consumption rate calculations”;
- (b) ym mharagraff (1) yn lle “dwelling” rhodder “building (other than a dwelling)”;
- (c) ym mharagraffau (2) a (3) yn lle “shall” ym mhob lle y mae'n digwydd rhodder “must”;
- (d) ym mharagraffau (2)(a) a (b) a (3)(a)(i) a (ii) yn lle “fabric efficiency rate for the dwelling” ym mhob lle y mae'n digwydd rhodder “primary energy consumption rate for the building”;
- (e) ym mharagraffau (2)(c) a (3)(a)(iii) yn lle “dwelling” ym mhob lle y mae'n digwydd rhodder “building”;
- (f) ym mharagraff (5) yn lle “fabric energy efficiency rate” rhodder “primary energy consumption rate”.



(7) Ar ôl rheoliad 27A mewnosoder—

**“Fabric performance values calculations**

**27B.**—(1) This regulation applies where a dwelling is erected and regulation 26B applies.

(2) Not later than the day before the work starts, the person carrying out the work must give the local authority a notice which specifies—

- (a) the target fabric performance values for the dwelling, calculated and expressed in accordance with the methodology approved pursuant to regulation 24;
- (b) the fabric performance values for the dwelling as designed, calculated and expressed in accordance with the methodology approved pursuant to regulation 24; and
- (c) a list of specifications to which the dwelling is to be constructed.

(3) Not later than five days after the work has been completed, the person carrying out the work must give the local authority—

- (a) a notice which specifies—
  - (i) the target fabric performance values for the dwelling, calculated and expressed in accordance with the methodology approved pursuant to regulation 24;
  - (ii) the fabric performance values for the dwelling as constructed, calculated and expressed in accordance with the methodology approved pursuant to regulation 24; and
  - (iii) whether the dwelling has been constructed in accordance with the list of specifications referred to in paragraph 2(c), and if not a list of any changes to those specifications; or
- (b) a certificate of the sort referred to in paragraph (4) accompanied by the information referred to in subparagraph (a).

(4) A local authority is authorised to accept, as evidence that the requirements of regulation 26B have been satisfied, a certificate to that effect by an energy assessor who is accredited to produce energy performance certificates for that category of building.

(5) In this regulation, “specifications” means specifications used for the calculation of the fabric performance values.”

(8) Yn lle rheoliad 28 (gwelliannau canlyniadol i berfformiad ynni) rhodder—

“28.—(1) Paragraph (3) applies to an existing building with a total useful floor area over 1000m<sup>2</sup> where the proposed building work consists of or includes—

- (a) the initial provision of any fixed building services; or
- (b) an increase to the installed capacity of any fixed building services.

(2) Paragraph (3) applies to an existing building where the proposed building work consists of or includes—

- (a) an extension; or
- (b) the extension of the building’s heating system or the provision of a fixed heating appliance, to heat a previously unheated space.

(3) Subject to paragraph (4), where this paragraph applies, such work, if any, shall be carried out as is necessary to ensure that the building complies with the requirements of Part L of Schedule 1.

(4) Nothing in paragraph (3) requires work to be carried out if it is not technically, functionally and economically feasible.”

## **Rhan 7 (effeithlonrwydd dŵr)**

8.—(1) Yn lle rheoliad 36 (effeithlonrwydd dŵr anheddau newydd) rhodder—

“36.—(1) The potential consumption of wholesome water by persons occupying a dwelling to which this regulation applies must not exceed 125 litres per person per day, calculated in accordance with the methodology approved by the Welsh Ministers.

(2) This regulation applies to a dwelling which is—

- (a) erected; or
- (b) formed by a material change of use of a building within the meaning of regulation 5(a) or (b).”

(2) Yn lle paragraff (1) o reoliad 37 (cyfrifo'r defnydd o ddŵr dihalog) rhodder—

“(1) Where regulation 36 applies, the person carrying out the work must give the local authority a notice which specifies the potential consumption of wholesome water per person per day calculated in accordance with the methodology referred to in that regulation in relation to the completed dwelling.”

## **Rhan 7A Systemau Llethu Tân Awtomatig**

9. Ar ôl Rhan 7 mewnosoder—

### **“PART 7A**

#### **Automatic Fire Suppression Systems**

##### **Provision of automatic fire suppression systems**

**37A.**—(1) This regulation applies where building work consists of the erection or material change of use of a building in relation to—

- (a) care homes, which means places at which a care home service, within the meaning of Part 1 of the Regulation and Inspection of Social Care (Wales) Act 2016, is provided wholly or mainly to persons aged 18 or over;
- (b) rooms for residential purposes other than rooms in—
  - (i) a hostel providing temporary accommodation to those who are ordinarily resident elsewhere;
  - (ii) an hotel;
  - (iii) a prison or young offender institution; and
  - (iv) a hospital;
- (c) dwelling-houses and flats,

subject to paragraphs (4) and (5).

(2) For the purposes of this regulation a material change of use comprises or includes a change of use within regulation 5 (a), (b), (c), (d), (g), (h) or (i).

(3) A building to which this regulation applies must be provided with an automatic fire suppression system which is installed and operates in accordance with the requirements set in regulation 37B.

(4) This regulation does not apply to buildings which are—

- (a) listed in accordance with section 1 of the Planning (Listed Buildings and Conservation Areas) Act 1990<sup>(1)</sup>;
- (b) in a conservation area designated in accordance with section 69 of that Act; or
- (c) included in the schedule of monuments maintained under section 1 of the Ancient Monuments and Archaeological Areas Act 1979<sup>(2)</sup>,

where installation of a fire suppression system would unacceptably alter their character or appearance.

(5) This regulation does not apply to temporary buildings with a planned time of use of two years or less.

#### **Requirements of automatic fire suppression systems**

**37B.** For the purposes of regulation 37A(3), the requirements of an automatic fire suppression system are the requirements set out in any document approved and issued under section 6 of the Building Act 1984 for the purpose of providing practical guidance as to the requirements of regulation 37A.”

“**44A.** The requirements of paragraph R1 (in-building physical infrastructure for high-speed electronic communications networks) of Schedule 1 apply to—

- (a) educational buildings and buildings of statutory undertakers, falling within

paragraphs (a), (b) or (c) of section 4(1) of the Act (notwithstanding section 4(1) of the Act);

(b) Crown buildings; and

(c) building work carried out or proposed to be carried out by Crown authorities.”

(2) Yn rheoliad 44B (esemptiadau rhag paragraff R1 o Atodlen 1) ym mharagraff (a)—

(a) ar ddiwedd is-baragraff (i) hepgorer “or”;
